



1 GENERAL DESCRIPTION


This manual explains the system configuration, installation and uninstallation procedures and manual browsing method of the Type SW0D5C-ACT-E ActiveX Communication Support Tool which operates on Windows.



2 SYSTEM CONFIGURATION

2.1 System Configuration

The following figure shows the system configuration.



2

POINT

- (1) Simultaneous use of this product on two or more personal computers is illegal. Therefore, you cannot use this product on any other personal computer than the one specified in the software registration card. However, the spare license key FDs are prepared for the unexpected, e.g., the hard disk of the personal computer is broken.

1-license product: SW0D5C-ACTKEY-E
These license key FDs are designed to be installable up to five times.

Multiple license product: SW0D5C-ACTKEY-EA
These backup license key FDs (of the same quantity as the number of the licenses you purchased) are packed with the product.

When you use this product on another personal computer, uninstalling the license key FD returns you one installation right.
- (2) By installing the license key FD, you can start the product. Refer to Section 3.1 "Installation" for details.
- (3) Never perform the following operations for the license key FD. Doing any of the operations will damage the license key FD.
 - FD formatting
 - File write onto FD
 - Copy of file on FD (copy to other drive, copy from other drive)
 - Deletion of file on FD, file name change, file attribute change
 - Execution of analysis tool (e.g. SCANDISK) to FD
- (4) Take charge of the license key FD so that you can identify the personal computer where it was installed, and store the FD carefully. If you lost the license key FD or the license key FD does not match the personal computer on which it was installed, you cannot install or uninstall the product.

2.2 Operating Environment

POINTS
(1) 3.5 inch (1.44MB) floppy disk drive is required to install the license key FD.
(2) Instruction for use of the online manual Addition of memory ensures more comfortable use.
(3) Instruction for use of the PDF data Use with addition of personal computer memory ensures comfortable operation.
(4) Any user program created on a personal computer in English environment may be used only on the personal computer in English environment.

3 INSTALLATION AND UNINSTALLATION


This chapter provides how to install and uninstall ACT.

3.1 Installation

POINT
Before installing ACT, always read "Section 3.1.2 Pre-installation instructions".

3.1.1 Installing Procedure

Install ACT in the following procedure.



- *1: When your personal computer is a notebook which is used by changing between a CD-ROM drive and an FD drive, change the drive after completion of application insatallation. Even after the personal computer has been powered off, you can install the license key FD.
- *2: Take charge of the license key FD so that you can identify the personal computer where it was installed, and store the FD carefully. If you lost the license key FD or the license key FD does not match the personal computer on which it was installed, you cannot install or uninstall the product. If lost, refer to Section 3.3.3.

REMARK

When the personal computer does not have a CD-ROM drive, refer to "Appendix 1 How to Install ACT after Copying It onto FDs" for the installation procedure.

3.1.2 Pre-installation instructions

On the personal computer on which ActiveX is not operable, an "Component Move Data Error" may occur during ACT installation, disabling normal completion of installation.

In such a case, close all applications and perform the following operation.

(1) Installation of Dcom95.exe or Axdist.exe

Execute Dcom95.exe or Axdist.exe provided for ACT.

Install ACT after executing the exe file and restarting the IBM-PC/AT compatible to make ActiveX operable.

The exe file to be executed on the corresponding operating system is indicated below.

- Windows 95/98: Dcom95.exe, Axdist.exe
- Windows NT 4.0: Axdist.exe

(Dcom95.EXE and Axdist.exe are in the "Dcom" folder on CD-ROM. If you want to use the file of the latest version, download it from the home page of Microsoft Corporation or use the file provided for the corresponding OS, VB or VC++.)

(2) If an "Component Move Data Error" occurs after "(1) Installation of Dcom95.exe or Axdist.exe"

An error may occur if the operation in (1) is performed since the system files*1 have been rewritten to illegal system files by another application.

If the error occurs after the operation in (1), take the following action for the corresponding operating system.

(a) Windows 95 and Windows NT 4.0

On Explorer, browse the system directory or system 32 directory and delete the system files*1.

Deletion may not be made since the files are used by the system.

If deletion cannot be made, wait for some time and restart deletion or use the startup disk to make deletion with the del command.

(b) Windows 98

Using the system file checker (SFC.exe), force the system directory of Windows to be overwritten by the system files*1 included on CD-ROM of Windows 98.

*1: The following system files may have been rewritten illegally.

MSVCRT.dll	MSVCRT40.dll	MFC40.dll	MFC42.dll
OLEPRO32.dll	OLEAUT32.dll	ATL.dll	

POINT

Deletion of the system files of Windows may affect the other applications. Delete the system files carefully.

3.1.3 Installing Operation

Use the following method to install ACT.

POINTS

(1) On the IBM-PC/AT compatible on which ActiveX is not operable, an error may occur during file transfer, disabling installation.
For the corrective action for occurrence of such an error, refer to "Section 3.1.2 Pre-installation instructions".

(2) Terminate all the other applications running under Windows before installation.

(3) When using Windows NT 4.0, log on as a user with the administrator attributes (for computer administration).



1) Start Windows after powering on the personal computer.


2) Start Explorer and click the drive in which the disk has been inserted.

Double-click "setup.exe".




If the left message appears, click **Cancel**, uninstall ACT, and then reinstall it.




If the left message appears, recover the license using the license key FD, and then install ACT.
If you have lost the license key FD, refer to Section 3.3.3 "If You Have Lost the License Key FD and Cannot Perform Uninstallation".




3) As the left screen appears, make sure that all applications have been closed and click the **OK** button. If the applications are running, close all running applications.



4) As the left screen appears, read the information and click the **Next>** button.




5) Enter the name and company name, and then click the **Next>** button.




6) Confirm the registered name and company name. If they are correct, click the **Yes** button. To make a change, click the **No** button to return to the previous screen.




- 8) Specify the installation Destination Folder.

If you change the destination folder, click **Browse** and specify a new drive and folder.




- 9) If the "ComponentMoveData Error Information" screen has appeared during installation as shown on the left, perform operation in accordance with the instructions in Section 3.1.2 "Pre-installation instructions ". Restart installation when the operation in Section 3.1.2 "Pre-installation instructions " is finished.




10) This completes the installation.
Then, install the license key FD and make ACT valid.




If the left screen appears, you must restart Windows.

- 1) Start Explorer and click the drive in which the license key FD has been inserted. Double-click "setup.exe". On Explorer, choose [Start]-[Programs]-[Windows Explorer].

- 3) Click the **Close** button. In this status, you can start the application.



3.3 Uninstallation

3.3.1 Uninstalling Procedure

Uninstall ACT according to the following procedure.



* 1: Use the license key FD which was used to install the product.

3.3.2 Uninstalling Operation

Use the following method to uninstall ACT.


(1) Uninstalling the license key FD

1) Insert the license key FD into the floppy disk drive.


2) Start Explorer and click the drive in which the license key FD has been inserted.

Double-click "setup.exe".

On Explorer, choose [Start]-[Programs]-[Windows Explorer].



3) Click the key picture.




4) Click the **Close** button.


In this status, the product is invalid and you can perform the operation in "(2) Uninstalling ACT".


- 1) Choose and double-click "Add/Remove Programs" in the Control Panel.
On Control Panel, choose [Start]-[Settings]-[Control Panel].

And then click Add/Remove Programs.






- 3) Check whether you will remove the software package or not.
When uninstalling, click **Yes**.
Uninstallation starts.
When not uninstalling it, click **No**.
This returns to the preceding screen.

* Components indicate the icons and files installed.
If you do not make the license key FD invalid, the following dialog box appears.



- 4) When this screen has appeared, click **No to All**.
The software package of only ACT is removed.
If you click the **Yes** or **Yes to All** button, the shared file of the MELSEC software packages will be removed and the other software packages may not operate properly.



- 5) When the removal finished message appears, click **OK**.


* If the unremoved file alarm is given, open "Windows Explorer", check the files and remove unnecessary files.
Note that if you remove necessary files accidentally, the other applications may not be started.

3.3.3 If You Have Lost the License Key FD and Cannot Perform Uninstallation

Make the product invalid in the following procedure if you have lost the license key FD or if the information of the registered product is corrupted. In that case, one installation right of the license key FD of the old product is lost. Refer to Section 2.1 "System Coniguration" for information on the handling and instructions for the license key FD.




1) Insert a new license key FD into the floppy disk drive and choose [Start]-[Run].



2) Enter "A:\SETUP /X" and click the button.



3) Click the key of the license tool dialog box.



4) Clicking the button abandons the valid status of the product.



5) Click the button.


6) Refer to Section 3.1.3 and perform installation.



Appendix 1 How to Install ACT after Copying It onto FDs


The following describes the method of installing the ACT on the personal computer when no CD-ROM drive is included in the peripherals.

On the CD-ROM, folders are prepared for each capacity allowed to be copied onto one FD so that the copying onto the FDs can be performed easily.

If the CD-ROM drive is selected using Explorer, Disk 1 through Disk n will appear on the screen. Prepare formatted FDs of the same quantity as the number of folders.

Setup.exe shown in the Route Directory of the CD-ROM must not be copied.


(1) Copy the data onto FDs.




1) Select the drive in which ACT has been set up.

Next, select all files stored in Disk 1 of ACT, and copy them onto the FD.

After the copying of Disk 1 has been completed, also copy the files stored in the other directories in the same manner. As setup.exe for FD is included in Disk 1, you need not copy setup.exe.



(2) Copying has been completed.



2) After the copying onto the FDs has been completed, insert the copied FD in the personal computer to be installed, and install ACT according to the messages shown on the screen.

For details of the installation operation, refer to Section 3.1.3 "Installing Operation".
